A Profile of Child Support Services Dependents in Alberta

Child and Youth Data Laboratory (CYDL) Longitudinal Project

Introduction

Child Support Services (CSS) helps single parents and parents in blended families reach child support payment agreements or obtain court orders for payment. Applicants are the parents who are seeking CSS payments from the respondents for support of dependents. Respondents are the parents from whom child support payments are being sought. Dependents are the children for whom child support is being sought from respondents. This report is an overview of the experience of CSS dependents (0 to 22 years) from 2005/06 to 2010/11.

Two main indicators, **Reason for Closure** and **Amount of Agreement/Order**, were profiled by a range of socio-demographic characteristics (e.g. gender, age, educational achievement, socio-economic status, etc.). These two indicators are expected to be related to determinants or outcomes for applicants/dependents. Thus, it will allow for the assessment of service needs among CCS clients.

Reason for Closure refers to the reason that was used to close the applicant/dependent's case file. For example, the Reason for Closure that is coded as 'the dependent has left the applicant's care' means that the dependent was no longer living with the applicant. As a result, the case file was closed.

Amount of agreement/order is the total dollar amount of child support stipulated in the agreement or order.

Key findings

- There were approximately 25,000 to 28,000 CSS dependents between 2005/06 and 2010/11. This accounts for approximately 2% of Albertans in the same age range in each study year.
- The percentage of CSS dependents who met or exceeded educational expectations (in the K-12 education system) increased over the study period.
- Compared to non-CSS dependents, a higher proportion of CSS dependents were both high cost health service users and mental health service users.
- In 2010/11, among CSS dependents who were at risk due to a past history of family violence and threats, a higher proportion received Child Intervention services.
- In 2010/11, among CSS dependents whose payment was between \$1 to \$250, a lower proportion met or exceeded educational expectations compared to CSS dependents whose payment was over \$750.

Background literature

Providing a context for the current report, this section highlights select literature focusing on child support payment services and their impact on children and families with low income.

Alberta's ministry of Community and Social Services offers the Child Support Services program to help single parents and parents in blended families reach child support payment agreements or obtain court orders for payment. Single parents and parents of blended families who are clients of Income Support or Assured Income for the Severely Handicapped are automatically referred to Child Support Services. Child Support services are also available to Albertans whose family income is less than a specified amount, where there is no existing support order, and where a child support worker determines there is potential for the other parent to pay support payments. There is no age eligibility restrictions for applicants. However, the age eligibility for the dependent is 0 to 18 years old, or up to 22 years of age if the dependent is attending school full time.

Research on child support services in U.S. have shown that low-income custodial families (i.e., incomes below the poverty threshold), custodial parents with less than a high school education^{1,5}, and custodial parents who were under 30 years old were more likely to receive child support program services^{5,6}. Usually, families in the children support program are female-headed^{1,2,5,6}.

Regular legally-mandated payments from a noncustodial to a custodial parent is crucial to improve the well-being of mothers and children^{1,2,3,4}. For example, the additional flow of income into a female-headed family allows a single mother to afford child care while she works and increases the child's access to health care services^{1,3}. Moreover, the child support income would benefit children in terms of their educational performance and socioeconomic attainment later in life^{1,4}.

In this report, the socio-demographic characteristics (e.g. age, gender, socio-economic status, residential mobility, etc.) and service use patterns (e.g. high cost health service, mental health service, Child Care Subsidy and Child Intervention, etc.) of Albertan CSS dependents were examined. The results will further our understanding of service use patterns of this vulnerable population.

Footnotes

- The amount of agreement/order analysis only includes the cases where the applicant/dependent obtained agreements or court orders for child support.
- The non-CSS dependents in this report refer to Albertan children and youths (0 to 22 years old) who were not in the Child Support Services program during the study period.

Ninety-five percent confidence intervals were calculated to enable comparison of statistical differences between groups. The Cochran-Armitage trend test was used to test trends over time. 
CSS Dependents Time Trend (Table 1; p.11)

This and the following analyses consider Child Support Services (CSS) dependents (0-22 years old) between 2005/06 and 2010/11.

• There were approximately 25,000 to 28,000 CSS dependents between 2005/06 and 2010/11. This accounts for approximately 2% of Albertans in the same age range in each study year.


- In 2010/11, 3.1% of Albertans in Edmonton and the Northwest regions were CSS dependents.
- The proportion of CSS dependents in the Northeast region decreased from 2005/06 to 2010/11 (from 1.7% to 0.6%).

Reason for Closure Trend (Table 3; p. 12)

For the purpose of analysis, the reasons were grouped into four categories: agreement/order for payments obtained, family violence, no potential for payment, the file was closed before conclusion. For detailed information about the reasons included in each category, please see *Definitions and Notes* on page 36.

- 35% to 38% of CSS dependents were in the Agreement/ order obtained category (i.e. agreements or court orders for payment were obtained on behalf of the CSS dependents) during the study period.
- For case files that were closed because there was no potential for payment (e.g., the respondent has no ability to pay), the percentage increased from 2005/06 to 2010/11.

Percentage of Child Support Services dependents by gender and reason for closure in 2010/2011




Gender by Reason for Closure (Table 4; p. 13)

 Approximately 50% female CSS dependents and 50% male CSS dependents were represented in each Reason for Closure category during the study period.


Educational Achievement by Reason for Closure (Table 5; p. 14)

- A lower proportion of CSS dependents met or exceeded educational expectations compared to non-CSS dependents.
- There was an increase among CSS dependents who met or exceeded educational expectations from 2005/06 to 2010/11, regardless of the Reason for Closure category.
- In 2010/11, a greater proportion of CSS dependents who were in the Agreement/Order obtained category met or exceeded educational expectations compared to CSS dependents in the Family violence and No potential for payment categories.

Percentage of Child Support Services dependents who met or exceeded educational expectations by reason for closure over time




Percentage of Child Support Services Dependents by reason for closure and age group in 2010/11



Age Group by Reason for Closure (Table 6a, 6b; p. 15, 16)

- Among CSS dependents who were in the Agreement/Order obtained category, the majority were between 0 to 12 years old.
- In comparison to non-CSS dependents, a lower proportion of CSS dependents was represented in the 18 to 22 age group.



High Cost Health Service by Reason for Closure (Table 7; p. 17)

For the definition of High Cost Health Service use, see *Definitions and Notes* on page 35.

- A higher proportion of CSS dependents were high cost health service users compared to non-CSS dependents.
- The rates of high cost health service users were similar among all categories of Reason for Closure.

Mental Health Service by Reason for Closure (Table 8; p. 18)

For the definition of Mental Health Service, see *Definitions and Notes* on page 35.

- A higher proportion of CSS dependents who were in the Agreement/Order obtained category used mental health services compared to non-CSS dependents.
- During the study period, a higher proportion of CSS dependents who were in the Agreement/Order obtained category used mental health services, compared to CSS dependents in the Closed before conclusion and No potential for payment categories.

Percentage of Child Support Dependents by reason for closure and residential mobility in 2010/11




Residential Mobility by Reason for Closure (Table 9; p. 19)

Residential mobility was determined using the number of unique postal codes in the Alberta Health Registry. Residential mobility is shown in 2010/11 (see Table 9 for mobility in each study year).

- In comparison to non-CSS dependents, a higher proportion of CSS dependents moved one or more times.
- Compared to CSS dependents in other Reason for Closure categories, among CSS dependents who were at risk due to a past history of family violence and threats, a higher proportion moved more than two times.

Socio-economic Status by Reason for Closure (Table 10a, 10b; p. 20, 21)

Percentage of CSS dependents by Reason for Closure and SES in 2010/11






 A higher proportion of CSS dependents was represented in the lowest socio-economic neighborhood compared to non-CSS dependents, regardless of the Reason for Closure category.

Alberta Health Care Registry by Reason for Closure (Table 11; p. 22)

The Alberta Health Care Registry includes all children and youth who are eligible to receive insured hospital and physician services. See *Definitions and Notes* (p. 35) for more inclusion details.

 During the study period, over 80% of CSSdependents were registered in the Alberta Health Care Registry.






Students with Special Needs by Reason for Closure (Table 12;p. 23)

- With the exception of CSS dependents in the Closed before conclusion category, the proportion of CSS dependents who were students with special needs in the other three Reason for Closure categories decreased from 2005/06 to 2010/11.
- In 2010/11, a higher proportion of CSS dependents who were in the Agreement/Order obtained category were students with special needs, compared to CSS dependents in other Reason for Closure categories.

Percentage of CSS dependents who received Child Care Subsidy by Reason for Closure over time




Child Care Subsidy by Reason for Closure (Table 13; p. 24)

- Among CSS dependents who were in the Agreement/ Order obtained category *or* who were in the Family violence category *or* who were in the No potential for payment category, the proportion receiving Child Care Subsidy decreased from 2005/06 to 2010/11.
- In 2010/11, a higher proportion of CSS dependents who were in the Agreement/Order obtained category were Child Care Subsidy recipients, compared to CSS dependents in other Reason for Closure categories.


Child Intervention by Reason for Closure (Table 14; p. 25)

- The proportion of CSS dependents who received Child Intervention services decreased from 2005/06 to 2010/11, regardless of the Reason for Closure category.
- In 2010/11, among CSS dependents who were at risk due to a past history of family violence and threats, a higher proportion received Child Intervention services compared to CSS dependents in other Reason for Closure categories.

Criminal Offence by Reason for Closure (Table 15; p. 26)

 The rates of CSS dependents with criminal offences were similar across all Reason for Closure categories.

Gender by Amount of Agreement/Order (Table 16; p. 27)

This and the following analyses only focus on CSS dependents whose files were closed because agreements or court orders for payment (>\$1) were obtained on behalf of the CSS dependents successfully.

Percentage of CSS dependents who met or exceeded educational expectations by amount of agreement or order for payment in 2010/2011







• In 2010/11, a higher proportion of CSS dependents whose payment was between \$751 and \$1000 had no residential moves, compared to CSS dependents whose payment was less than \$750.


- **Age**, **gender**, and postal code (translated into Statistics Canada **dissemination areas**) were provided for each individual by each participating program. In the case of discrepancies between programs, the most common value for an indicator was chosen. In the event of two or more most common values, the value for the indicator was chosen randomly from the most common values.
- The **Alberta Health Care Registry** (also known as the Alberta Health Care Insurance Plan—AHCIP) includes all study participants (aged 0 to 30) who are eligible to receive insured hospital and physician services.
- **Child Intervention** services are focused on meeting the safety and well-being of children and helping families and communities to meet these needs. The Child Intervention Program provides services to children and youth between the ages of 0 and 17 years who are or may be at risk of being abused, neglected or otherwise in need of intervention. As well, young adults (18-22 years of age) may also be eligible for post -intervention supports through the use of Support and Financial Assistance Agreements to help them transition to adulthood.
- Individuals with **criminal offences** include those (aged 12 or older) charged with offences under various federal statutes.
- Cross-ministry analyses included only study participants who were linked across the relevant programs. This means that not all participants in the project were represented in every analysis. As well, only participants with a value for a given indicator were included in analyses involving that indicator (i.e., missing values were excluded).
- Educational achievement was computed by Alberta Education using age, grade 3, 6, and 9, school type, special education codes, provincial achievement test scores, home education status, number of high school credits earned, number of higher level courses taken, average grade in higher level courses, possession of an Alberta Education certificate or diploma, and Alexander Rutherford scholarship eligibility. Educational achievement was categorized as above, meeting, or below expectations for a student's age and grade. An educational achievement rating was not available for youth in 'other' schools (accredited post-secondary institutions offering high school courses for credit to adults; most youth in these schools were between 18 and 20 years), for home-schooled high school youth with no credits, and for students in grades lower than 3.
- **High cost health service use:** Cost estimates per type of service across physician visits (general practitioner or specialist), ambulatory care visits (emergency or other ambulatory care), and hospitalizations (by type of service) were obtained from the Canadian Institute for Health Information. Estimated costs per visit were summed across all visits for each individual. High cost health users were those in the top 5% of estimated costs for their age groups and genders.
- Mental health service was defined by the presence or absence of mental health diagnosis codes (Two or more ICD-9: 290-309.9, 311-314.9, 316, or a single ICD-10CA: F00-F06.9, F09-F69, F84-F99, G31.2, G44.2, R41.0) in Alberta Health and Wellness' databases (Inpatient—Discharge Abstract Database, Ambulatory Care, and Practitioner Payments), or in the Family Support for Children with Disabilities (FSCD) or the Assured Income for the Severely Handicapped (AISH) information systems. Only Albertans who were registered with the Alberta Health Care Insurance Plan for the full fiscal year or who had a mental health service with FSCD or AISH were included. Mental health service use is a proxy for presence of a mental health condition; some youth with mental health conditions may not have accessed mental health services in Alberta during the year, and some mental health service use may have occurred for youth who did not in fact have mental health conditions.


Definitions and notes (continued)

- Reason for Closure Client files are closed with the file closure reason which reflects the current situation of the applicant. There are 21 closure reasons, which are grouped into four categories for the purpose of analysis: (1) Agreement/Order: order/agreement obtained by the applicant/dependent; (2) File closed before service conclusion, which include the following reasons: assistance file closed; the applicant decides to end services; non-compliant. (3) No potential for payment: the respondent deceased; the respondent does not live in a reciprocal jurisdiction; the applicant is divorced and support is reserved; unable to identify person responsible; the applicant does not know the whereabouts of the person; the applicant and respondent reconciled; the dependent has left applicant's care; the respondent was excluded by DNA testing; person responsible has no ability to pay; wrong CSS applicant referral. (4) Family violence: the applicant or the children are at risk due to a past history of threats and violence.
- Children's Services and Community and Social Services delivery **regions** were used for regional analyses. Dissemination areas from the 2006 Statistics Canada Census were used to

determine region. Those with missing dissemination areas are excluded from analyses. There are seven regions (Northwest, Northeast, North Central, Edmonton, Central, Calgary, South); the boundaries for these regions are shown on the map.

• **Report population:** For this report, age groups were equated across study years. This meant that individuals over the age of 25 years were excluded from analyses by year, because no study participants were older than 25 years in the first study year. "All years combined" analyses did include these oldest study participants, however.





- **Study population:** The study included individuals with a date of birth between April 1, 1980 and March 31, 2011 and who received services from one of the programs in the study or were registered in the Alberta Health Care Insurance Plan between April 1, 2005 and March 31, 2011. The youngest study participants were those born in the last study year. The oldest study participants were 25 years old at the end of the first study year and consequently 30 years old at the end of the last study year.
- **Students with special needs** (aged 2.5 to 19) receive special education programming services.
